co-heads of its distressed investing practice.

Ringer began her legal career with Kramer Levin, arriving as an associate in October 2010. She was elevated to partner in 2019.

She was retained as counsel to the official committee of unsecured creditors in the August 2022 Chapter 11 filing of pharmaceutical company [Endo International plc](#). In the September 2019 case of industry peer [Purdue Pharma LP](#), Ringer was counsel to the ad hoc committee of governmental and other contingent claimants. She also served as counsel to the creditors' committee in the proceedings of [Gulfport Energy Corp.](#) that began in November 2020.

Ringer received her B.S. from the University of Michigan in 2007. She went on to earn her J.D. from Maurice A. Deane School of Law at Hofstra University in 2010.

Eggermann represents the ad hoc group of first-lien creditors in the Chapter 11 proceedings of Sinclair Inc. (SBGI) subsidiary [Diamond Sports Group LLC](#), which looks to reduce its debt and become a standalone company. He was retained by the ad hoc group of government entities holding opioid claims in the 2020 bankruptcy filing of [Mallinckrodt plc](#). According to Kramer Levin, he also represented the creditors' committees during the Chapter 11 proceedings of [Eagle Hospitality Properties Trust Inc.](#) and [California Pizza Kitchen Inc.](#)

Eggermann earned his B.A. from LIU Post in 1998. He went on to receive his J.D. from [New York University School of Law](#) in 2002.
