Alexander studied law at the universities of Munich, Paris and Vienna and was a Fulbright Scholar at Columbia University, where he obtained his LL.M. in 1970. He joined Rogers & Wells in New York upon graduation, moving to its Paris office in 1974. Alexander was managing partner of the Paris office from 1976 to 2016 and the driving force behind the office's decision to join Kramer Levin in 2000.
