

# In Memoriam: Ezra G. Levin

Feb. 10, 1934 - Oct. 31, 2022

We mourn the loss of our former senior partner, colleague and friend Ezra G. Levin, who passed away on Monday, Oct. 31, 2022. He was 88.

Ezra joined Kramer Levin in 1979 as a name partner. At the time of his retirement in May 2020, he was the firm's chairman emeritus. A consummate strategist, a superb corporate lawyer and, above all, a gentleman, he was a go-to adviser for boards, CEOs and other senior executives on their most sensitive and complex matters. There was no more effective advocate for clients than Ezra, but he always represented their interests with a quiet and unflagging dignity that reflected his deep personal integrity.

An article was published in the Nov. 4 and Nov. 6 editions of *The New York Times*. Ezra's colleagues and friends shared their memories of Ezra.



# Kramer Levin Obtains Mansfield Rule 5.0 Certification, Commits to 6.0 **Certification Process**

Kramer Levin is pleased to announce that the firm has obtained Diversity Lab's Mansfield Rule 5.0 certification and is continuing its participation by seeking the newest certification level, Mansfield Rule 6.0. Launched in 2017, the goal of the Mansfield Rule is to boost the representation of diverse attorneys in law firm leadership by broadening the pool of candidates considered for those opportunities.

To be certified for Mansfield Rule 5.0, participating law firms must, among other requirements, commit to considering at least 30% women, attorneys from underrepresented racial and ethnic groups, LGBTQ+ attorneys, and attorneys with disabilities for leadership roles, as well as including at least the same amount in critical pipeline activities and producing transparent leadership role descriptions.
